Criminal Justice

Preamble

The Avalon Criminal Justice High Court is the highest female justice organ to prosecute and punish male crimes against femininity. It is founded on the natural law of absolute superior hay of the female gender over all men.

It serves as atonement for the millenniums-long oppression of women by men and secures revenging justice through relentless corporal punishment of male-dominant behaviour.

Due to its comprehensive means for prosecution (legislation, investigation and evidence, indictment, conviction and execution of punishments) the Avalon Court is not only an organ of case law but also of criminal organization.

§1.

Objects of Prosecution

All men who physically or psychologically execute violence against women;
All men who show lacking respect towards their female partners or other women;
All men who self-governing dominantly ignore the natural supremacy of women over men;
All men who unleash their impulsive, obsessively unrestrained sexual phantasies;
All men who degrade women to objects of their voluptuous desires;
All men who in spirit and deeds disregard their devote duties as slaves
commit crimes against femininity, i.e. against the Avalon Laws. They are prosecuted by the Avalon High Court, called to account, and sentenced to always legitimate corporal punishments.

§2.

The Lady Judges of the Avalon High Court

The Avalon High Court acknowledges the separation of powers between prosecution and the independent judgement of the court. The prosecution is represented by her Highness Lady Prosecutor based on the criminal investigation. Her Highness Lady Judge pronounces the verdict based on proven evidence and the confession of the defendant. The sovereign Mistresses of the Court, Lady Mercedes and Lady Marlon represent both functions, either as Prosecutor or Judge. The defendant has no entitlement for a public defender.

§3.

Entitlement for Lawsuit

Only women are entitled for lawsuit: the defendant's affected wife/partner or any other woman injured by the defendant and the Highest Lady Prosecutor or any other Lady being informed about such crimes. Likewise, the court will accept a penitent self-complaint of a male creature, which committed such crimes (without such action creating any claim for extenuation)

§4.

Scope of the Avalon Legislation

Following the deduction of the Avalon Laws from the natural supremacy of women over men, it is conclusive that the scope of the Avalon Jurisdiction cannot be limited to the territory of the Avalon Residence only, but must be universally applied. Crimes against feminity, as defined in the court's laws, are consequently prosecuted also beyond the Avalon Territory, as soon as the Court is informed about such crimes. Even the enforcement of corporate punishments can happen outside the Avalon Territory (e.g. through remote disciplinary action, remote education etc.)

§5.

Acknowledgement of the Validity of the Court

Upon entering the criminal prosecution, the defendant is forced to explicitly acknowledge the validity of the court for his case. Through a written, binding and irrevocable declaration of consent the defendant submits himself to the verdict, whatever it will be and whatever the resulting consequences of prison enforcement will be. In case of a defendant's refusal to engage in the criminal prosecution, the Avalon court will apply coercion.

§6.

Differentiation from other Criminal Courts

The Avalon Criminal Court is not concerned with the prosecution or punishment of crimes related to Civil Law. The Avalon Court does not question the state monopoly of violence. Since however, those man-made laws do not prosecute crimes against feminity, the Avalon Court defines its female monopoly of violence as an indispensable supplement to the state courts.

Criminal Proceedings

§1

Lawsuit

Based on the denunciation of a crime against the Avalon Laws, the Lady Prosecutor will start to collect evidence, interview potential witnesses of the crime, and interrogate the offender.

§2

Provisional Imprisonment

In case the defendant is suspected to hide evidence during the investigation, the Lady Prosecutor can prescribe provisional imprisonment in the Avalon dungeon for a maximum of 30 days. Latest after this time frame the indictment will be announced. During the provisional imprisonment the suspect is kept in dark insulation, chained in a single dungeon, to prevent him from contacting other offenders. The duration of the provisional imprisonment will not be accounted for in the final verdict.

§3

In Principle Assumption of Guilt

The prosecution is based on the principal assumption of the defendant being guilty. The simple complaint of women accusing a suspected man is sufficient to assume a male creature guilty. The trial at court only serves to substantiate his guilt through evidence, testimony by female witnesses and the confession of the defendant, and to evaluate the appropriate punishment.

§4

Proof of Evidence

Potential proof of evidence must be presented to the Court during the trial, and potential female witnesses must be named. A male creature can never be a witness.

§5

Coercion

In order to extort a comprehensive confession from the dependant, the application of high-need torture as a means of coercion is explicitly allowed on demand of the prosecutor.

§6

Indictment

After evidence is achieved and the witnesses have been heard, the prosecutor reveals the indictment against the defendant and fixes the date of the trial. The defendant is not entitled to see the criminal files before the trial.

§7

Purification Arrest

The defendant must arrive at the Avalon High Court at least six hours before the trial begins. In order to be properly prepared for the trial and to purify his criminal soul, the defendant will be shackled, naked, in a dark cell of the subterranean Avalon dungeon.

§8

Non-Appearance at Court

In case the defendant does not show up at the trial, the Avalon Court will apply means of coercion (e.g. extortion) in order to guarantee a properly conducted trial with the defendant present.

§9

Public Trial

The trial is public for all women who personally want to testify the application of punishing justice against male offenders and do not want to miss a show-trial against male crimes conducted by the Ladies' High Court of Avalon.

§10

Right of Defence

The defendant is presented to the court naked and in shackles. During the trial he must kneel in front of the Lady Prosecutor and the Lady Judge. To prevent the defendant from interrupting the trial by interjection he is gagged. The gag will be removed only in case the Lady Prosecutor or Lady Judge asks for the defendant's comment about his crimes. Only then has the defendant the right to self-defence.

§11

Presentation of Evidence

The Lady Prosecutor presents the accusations and shows the points of evidence. The Lady Judge listens to the witnesses as nominated by the Prosecution.

§12

Enforced Confession

In case the defendant did not present a comprehensive confession of his crimes before the trial started, the Lady Judge can order coercion (e.g. torture) to enforce a confession.

§13

The Ruling

Based on the defendant's confession, the evidence, and the testimony of the witnesses, the Lady Judge pronounces the ruling and defines the sentence, thereby reflecting all committed crimes and applying the appropriate punishment to each individual felony.

§14

Satisfactory Punishment

The sentences of the Avalon Court are harsh and always rightful. The verdict, the sentence and the prison enforcement reflect the character and dimension of the committed crime.

§15

Request for Grace

The condemned defendant may present a request for grace to the Lady Judge, after the sentence is pronounced. There is, however, little chance that grace will be granted, as this depends on the Lady Judge's arbitrariness.

§16

Acceptance of the Punishment

The condemned offender expresses his thanks for the sentence and explicitly accepts the punishment. He will then be led back into the dungeon where he will wait, in shackles, for the execution of his punishment(s).

§17

Prison Enforcement

Prison enforcement must start not later than 24 hours after the sentence was pronounced. Depending on the character of the crime as reflected in the verdict, the execution of punishment will be in public.

§18

Written Verdict

The Lady Judge's verdict is documented in writing. On request, the condemned male creature is entitled to receive a copy of the verdict.

§19

Multiple Sentencing

The defendant can be sentenced and punished multiple times for the same crime.

§20

Right of Appeal

There exists no right of appeal against the rulings of the Avalon High Court, as it is the highest organ of female jurisdiction over men.

§21

Court Fees

The Trials of the Avalon Court are free of fees. The cost of prison enforcement will however be invoiced from the condemned offender.

Criminal Law

Preamble

§1.

The Avalon Legislation serves to secure, that the natural law of absolute superior hay of the female gender over all men is not offended. It describes the crimes against this universal law of nature and sets the framework for the prosecution of such crimes.

§2.

In addition, the Avalon Laws intend an educational ambition:

The existence of a legislation, which defines punishable, women scorning behaviour, does not allow male creatures any longer to refer to ignorance or innocence. Through the sheer existence of these laws every male creature knows, how to behave and at which point his crimes against feminity will start. This allows the Avalon Court to prosecute the offenders of such laws with much more harshness, and to lead those punishable male creatures back to the path of virtue, reverence and humility towards the female gender.

§3.

The most frequently committed crimes against feminity include male violence, disrespect, disregard, humiliation, defamation, dishonouring and disgrace of women. The punishments therefore must reflect the character of these crimes. Through the application of violence and torture, humiliation and disgrace shall the male creature and its soul be purified to such extend, that it will never ever again question the natural supremacy of women over men.

1. Crimes against Feminity

§1

Physical Violence against Women

The female body is untouchable. Any form of physical aggression against the female body, any violence against a woman or women will be prosecuted as an absolutely inexcusable capital crime and is punished with maximum capital penalty. No mitigating circumstances such as jealousy, alcoholics, drugs, sexual frenzy or others will be taken into account.

§2

Psychological Violence against Women

The female psyche is untouchable. Subtle forms of violence against women, such as psychical oppression, mental subjection, revocation of love, denial of love, and exploitation of the female ability to love, are morally reprehensible to the highest degree and are strictly prohibited. These crimes will be punished through highly effective psychological punishments such as insolation arrest in darkness, including complete deprivation of sensory perception.

§3

Humiliation and Degradation of Women

Male creatures, which humiliate and expose women through defamation, obscene comments, and salacious talk or in other ways offensive remarks, are guilty of humiliation and degradation of women and will be punished by similar means of public humiliation, such as pillory, stocks, show cage, being spit at, etc.

§4

Crimes of Thought against Women

Male creatures, which abuse women through voluptuous, unbridled thoughts for their outrageous sexual or otherwise unpleasant phantasies, are guilty of the crime of thought against women. As these crimes are difficult to prove by physical evidence, the menace or factual application of torture is demanded to extort a confession of these crimes.

§5

Lechery and Creepiness

Male creatures, which harass women privately or in public through brazenly creepy stare and voluptuous body language, are guilty of lechery and creepiness. Solely the offended woman determines at which point the limit between desired admiration and outrageous creepiness is overstepped. Such crimes will be punished by extreme bondage and blindfolding in order to prevent such gestures and stares by force.

§6

Misuse of Female Clothing (Fetishism)

Male creatures, which steal female clothing (bras, bodices, slips, girdles, corsets, nylons, high heels, garments etc.) without permission, or purloin such female attributes temporarily to misuse them for their pervert delectation, are guilty of theft and tainting of specifically female property. This heavy crime is punished by applying the respective attributes as means for bondage, gagging, blindfolding etc.

§7

Disrespectful Behaviour

Male creatures, which face women without the imperative obeisance and humility, or treat them without respect, or insult and despise women with words and deeds, are guilty of the crime of disrespectful behaviour. They will be punished through publicly executed whipping.

§8

Lying to Women

Male creatures, which, with misleading intentions, tell lies to women, or withhold the full truth for bad motives to gain a personal profit on cost of a woman, will be sentenced to corporal punishment and torture in order to extort a confession of the full truth.

§9

Questioning the Natural Female Supremacy over men

Male creatures, which question the absolute superior hay of the female gender over all men through their deeds, words, or gestures, will be sentenced to incarceration and heavy corporal punishment. It does not matter in this regard, whether the crime was committed intentionally or negligently. Solely the subjective perception of a woman, that a man does not sufficiently appreciate her supremacy, is sufficient for sentencing and punishment.

§10

Avoidance of a Punishment as ordered by a Woman

Male creatures, which refuse to accept a punishment as sentenced by the Avalon High Court or by a woman outside the court, or men who try to escape such punishment through getaway, absence at the trial date, or pretending false facts (e.g. disease), will be forced through means of enforcement to take on their punishment. The original sentence will be automatically doubled in this case.

§11.

Insulting the Ladies of the Avalon Court

Male creatures, which insult the Highest Lady Prosecutor or Highest Lady Judge through not- or delayed appearance at the date of the trial, or through disrupting the trial procedures, or questioning a sentence of the court, will be punished by ordinance.

2. Crimes against the Status of Slave

The status of slave includes special duties towards his Lady owner. Violation of these duties will be penalized by means of special laws, as below. The Avalon Court will sentence such crimes according to the size of the felony. The Lady owner of the condemned slave can extend the sentence any time at will.

§12

Lack of Submission

A Slave who demonstrates through words and deeds, that he does not live up to full submission under his Lady owners' domination, and continues with putting his male egoistic self-importance over the interests of his Lady, commits this crime. Solely his Lady will define, whether, and on what occasion such lack of submission is the case.

§13

Non-Fulfilment of Duties

A slave who does not fulfil a duty as ordered by his Lady, or does not fulfil such order to his Lady's full satisfaction, or who tries to shirk away from a duty, will be punished for such crime.

§14

Incompetence and Idleness

A slave who shows stupidity or negligence at work, or who, doing a job much too slow, shows signs of idleness, or who shows himself incapable of completing a task, will be heavily punished. Solely his Lady will define, whether, and on what occasion such incompetence or laziness is the case.

§15

Unfulfilled Promises and Expectations

A slave who does not honour promises given to his Lady owner, or does not fulfil her expectations is guilty of this crime. When it comes to the punishment, it is of no relevance, whether the slave did actually give that promise, or whether he actually did know about his Lady owners' expectations.

§16

Disregarding one's Lady

A slave who is not always, any time with body and soul at his Lady owner's disposal, or does not read every desire from his Lady's lips anytime, is guilty of the severe felony of disregarding his Lady owner.

§17

Unauthorised Erection, Masturbation

A slave who provokes an erection of his cock, or masturbates without explicit permission from his Lady owner, misuses the property of his Lady owner for selfish profit and will therefore be heavily punished. Solely when specifically ordered by his Lady, and exclusively for her pleasure, in combination with a punishment, is a slave allowed to masturbate.

§18

Insubordination

A slave who does not follow, or even revolts against a command of his Lady owner commits the crimes of insubordination and disobedience. Through harsh corporal punishment the slave will be educated to never ever commit these crimes again.

§19

Mitigating Circumstances

The Lady Judge may consider mitigating circumstances when assessing the crime and the adequate sentence. Such mitigating circumstances are:

- When the defendant voluntarily offers a comprehensive confession, which has not been extorted by torture;
- When the defendant shows credible remorse about his crime(s)
- When the defendant apologises in public for his crime(s)
- When the defendant offers credible atonement for his crime(s)

§20

Aggravating Punitive Circumstances

The Lady Judge must consider all punitive and aggravating circumstances, when assessing the crime and the adequate sentence. Such aggravating circumstances are:

- When the defendant has planned the crime;
- When the defendant has already been sentenced by the court for one or multiple crimes;
- When the defendant renounces his crime or parts of it, and refuses a complete confession of his crime(s);
- When the defendant obstructed the criminal investigation process.

Corporal Punishments

The Lady Judge can anytime arbitrarily alter the framework of punishments for crimes against feminity (as described under §1 to §11) to more harshness.

The Lady Judge is however obliged to reflect the character of the crime in her evaluation of the appropriate punishment. The format and the seriousness of the punishment must reflect the format and seriousness of the crime.

In case a convicted criminal is not in the situation to stand a full corporal punishment (due to a disease or other significant reasons), the Lady Judge may choose an alternative way of punishment e.g. incarceration etc.

Forms of Punishment

§1

Corporal Punishments

All corporal punishments are executed with extreme severity and harshness. In case a corporal punishment cannot be executed immediately after the verdict, it has to be caught up at the next possible date. In case the convicted criminal cannot suffer the full punishment at a time, it will be repeated to full extend at the next possible date.

§1.1

Slaps on the face

Slaps on the face are executed with leather gloves on the naked face of the convicted criminal, who kneels in front of the executing Lady. The Lady Judge defines the amount of slaps.

§1.2

The Cane

The executing Lady whips the convict with the cane on his naked butt. For that purpose the convict is fixed on the sin-bin. The Lady Judge defines the starch of the cane and the amount of strokes.

§1.3

The Punishment Alley

The naked convict crawls on his knees through an alley, which is formed by six Ladies, who strike the convict with their canes. He has to cross the alley several times until the stated amount of strokes has been achieved.

§1.4.

The Whipping

The naked convict is bound to the punishment trestle, the sin-bin or the punishment pole. The whip strokes are directed to the spine of the convict. The Lady Judge defines the length and starch of the whip and the amount of strokes.

§2.

The Pillory

The convict is locked in the public pillory and exposed in a standing, kneeling or lent over but immovable position. Any woman is entitled to tantalise, whip, torture or punish the convict in any imagineable way, to take revenge for the male creature's crimes against women. The Lady Judge defines how long the convict is locked in the pillory.

§3.

The Incarceration

The convict is incarcerated in the subterranean Avalon dungeon. During the period of his incarceration he only gets water and old bread as the only food. The incarceration can be aggravated through application of shackles, chains, or regular corporal punishment. The Lady Judge defines the time period and the form of imprisonment: cell (also dark cell); iron cage; closed box; earth hole etc.

§4.

Forced Labour

If convicted to forced labour the criminal must serve the labour on the Avalon territory. The working hours are 16/day; the night is spent in dungeon. Forced labour is executed in shackles. The convict will be remote controlled through electric shock.

§5.

Conditional Punishment

The Lady Judge can make a verdict conditional to a probation time, i.e. a part or the whole punishment is suspended for he period of probation. In case the convict does not commit further crimes during this period, the punishment will definitely be suspended. In case the convict continues to commit crimes, or does not comply with the conditions of the probation, he will be punished immediately.

§6

Unconditional Punishment

In the usual case that the verdict means unconditional punishment, the sentence will be executed on the convict immediately without delay.
